Title: AN ACT CONCERNING CONTRACTS BETWEEN HEALTH CARE PROVIDERS AND CONTRACTING HEALTH ORGANIZATIONS.

Statement of Purpose: To require certain information to be included with a contract offered by a contracting health organization to a provider, to prohibit a contracting health organization from making unilateral changes to a contract more than once a year, and to prohibit a contracting health organization from canceling or rescinding authorization for a service or demanding the return of payment for an authorized service more than one year from the date of the filing of a clean claim or the date of payment.
