- 2 In line 18, insert a closing bracket after "hundred" and after the
- 3 closing bracket insert "four hundred fifty"
- 4 In line 61, after the period insert the following: "A municipality or
- 5 local or regional board of education serving a municipality that has
- 6 entered into an agreement with a private vendor for the installation,
- 7 operation and maintenance of a live digital video school bus violation
- 8 detection monitoring system shall use amounts remitted to such
- 9 municipality in accordance with subsection (e) of section 51-56a of the
- 10 general statutes, as amended by this act, in respect to the violation of
- 11 section 14-279 of the general statutes, as amended by this act, to
- 12 reimburse the private vendor for the expenses for installing, operating

13 and maintaining the monitoring system."

14 Strike sections 3 and 4 in their entirety

20 (NEW) (e) The state shall remit to the municipalities in which the
21 violation occurred all fine amounts received in respect to the violation
22 of section 14-279, as amended by this act, after crediting twelve per
23 cent of such fine amounts to the Special Transportation Fund
24 established under section 13b-68 of the general statutes, and crediting
25 eight per cent of such fine amounts to the General Fund. Each clerk of
26 the Superior Court or the Chief Court Administrator, or any other
27 official of the Superior Court designated by the Chief Court
28 Administrator, shall, on or before the thirtieth day of January, April,
29 July and October in each year, certify to the Comptroller the amount
30 due for the previous quarter under this subsection to each
31 municipality served by the office of the clerk or official.
