**Title:** AN ACT CONCERNING REVISIONS TO THE STATE CODES OF ETHICS.

**Statement of Purpose:** To permit the Office of State Ethics to recover the amount of any financial benefit received by a state contractor for certain violations, to add a violation of section 1-101nn of the general statutes to the list of violations that are grounds for disqualifying a state contractor, to give the office the authority to interpret Parts III and IV of chapter 10 of the general statutes, to redefine "gift" for purposes of the codes of ethics, to exempt the office from certain fee requirements, and to make other changes to the codes of ethics.
