"AN ACT CONCERNING ANIMAL-ASSISTED THERAPY SERVICES."

1 Strike everything after the enacting clause and substitute the
2 following in lieu thereof:

3 "Section 1. Section 17a-22ee of the general statutes is repealed and
4 the following is substituted in lieu thereof (*Effective from passage*):

5 (a) For purposes of this section: []

6 (1) "Animal-assisted activity" means any activity that involves a
7 team consisting of a registered handler and therapy animal interacting
8 with individuals in the state;

9 (2) ["animal-assisted therapy"] "Animal-assisted therapy" means

10 goal-directed intervention in which [animals are] a team consisting of a
11 therapist and a therapy animal, or a therapist, registered handler and a
12 therapy animal, is used as an integral part of the [crisis response]
13 therapy process to aid individuals who have (A) experienced mental,
14 physical or emotional trauma, (B) witnessed, or have been a victim of,
15 an act of violence, or (C) behavioral health care needs;

16 (3) ["animal-assisted therapy community"] "Animal-assisted activity
17 community" means the local or regional entities capable of providing
18 animal-assisted therapy or animal-assisted activities to individuals
19 within the state; [and]

20 (4) ["animal-assisted activity organization"] "Animal-assisted
21 activity organization" means any entity involved in training,
22 evaluating [and] or registering members of the animal-assisted
23 [therapy] activity community; [.]

24 (5) "Animal-assisted critical incident response team" means a team
25 of registered handlers and therapy animals that (A) has been identified
26 by the Department of Children and Families, and (B) is capable of
27 providing animal-assisted activities to individuals during and after
28 traumatic events;

29 (6) "Registered handler" means an individual who has been
30 screened, trained and registered by a national animal therapy
31 organization to engage in animal-assisted activities or animal-assisted
32 therapy, or both;

33 (7) "Therapist" means any (A) physician licensed pursuant to
34 chapter 370, (B) psychologist or professional counselor licensed
35 pursuant to chapter 383, (C) marital and family therapist licensed
36 pursuant to chapter 383a, or (D) clinical social worker or master social
37 worker licensed pursuant to chapter 383b; and

38 (8) "Therapy animal" means any animal trained to provide comfort
39 to individuals who have (A) experienced mental, physical or emotional
40 trauma, (B) witnessed, or have been a victim of, an act of violence, or

41 (C) behavioral health care needs.

42 (b) Not later than January 1, [2014] 2016, the Commissioner of
43 Children and Families shall, within available appropriations, develop
44 and implement training for certain employees of the Department of
45 Children and Families and mental health care providers on (1) the
46 healing value of the human-animal bond for children, (2) the value of
47 therapy animals in dealing with traumatic situations, and (3) the
48 [benefit of an] benefits of animal-assisted activities and animal-assisted
49 therapy. [program.]

50 (c) Not later than January 1, [2014] 2016, the Commissioner of
51 Children and Families, in consultation with the Commissioner of
52 Agriculture and within available appropriations, shall [identify a
53 coordinated volunteer canine crisis response team. Such team shall
54 consist of various handlers and canines that have been trained,
55 evaluated and registered by an animal-assisted activity organization to
56 provide aid to individuals during and after traumatic events] develop
57 a protocol to identify and mobilize animal-assisted critical incident
58 response teams throughout the state. Such [team] teams shall operate
59 on a volunteer basis and shall be available to provide animal-assisted
60 [therapy] activities to individuals during and after traumatic events
61 within twenty-four hours of receiving notice to do so.

62 (d) Not later than July 1, [2014] 2016, the Commissioner of Children
63 and Families, in consultation with [the Governor's Prevention
64 Partnership and] the animal-assisted [therapy] activity community,
65 shall, within available appropriations, develop [a crisis response
66 program utilizing the services of the coordinated volunteer canine
67 crisis response team identified pursuant to subsection (c) of this section
68 to provide] a protocol to (1) identify and credential animal-assisted
69 activity organizations and providers of animal-assisted therapy in the
70 state, and (2) utilize animal-assisted activities and animal-assisted
71 therapy to provide aid to children and youths living with trauma and
72 loss."
