"AN ACT CONCERNING THE STATE BUDGET FOR THE BIENNIUM ENDING JUNE THIRTIETH, 2021, AND MAKING APPROPRIATIONS THEREFOR, AND IMPLEMENTING PROVISIONS OF THE BUDGET."

- 12 After the last section, add the following and renumber sections and
- 13 internal references accordingly:
- 14 "Sec. 501. (NEW) (Effective from passage) (a) Notwithstanding the
- 15 provisions of chapter 157 of the general statutes, no grant authorized
- 16 under said chapter shall be paid during the fiscal year ending June 30,
- 17 2021. Notwithstanding the provisions of chapter 157 of the general
- 18 statutes and section 3-69a of the general statutes, all moneys in the
- 19 Citizens' Election Fund shall be transferred from said fund and
- 20 credited to the resources of the General Fund for the fiscal year ending
- 21 June 30, 2021.
- 22 Sec. 502. (Effective from passage) The State Contracting Standards
- 23 Board shall develop a procurement plan for state contracting agencies
- 24 to achieve twenty-five million dollars in savings for the fiscal year
- 25 ending June 30, 2020, and twenty-five million dollars in savings for the
- 26 fiscal year ending June 30, 2021. Not later than August 1, 2019, the
- 27 State Contracting Standards Board shall submit such plan to the
- 28 Governor and the Secretary of the Office of Policy and Management
- 29 for implementation of such plan. The Secretary of the Office of Policy
- 30 and Management may make reductions in allotments to state
- 31 contracting agencies during said fiscal years to achieve such savings.
- 32 Sec. 503. (Effective July 1, 2019) The Secretary of the Office of Policy
- 33 and Management may make reductions in allotments to the
- 34 Department of Mental Health and Addiction Services, for the fiscal
- 35 year ending June 30, 2021, in order to achieve privatization savings in
- 36 the General Fund of \$4,250,000 during the fiscal year ending June 30,
- 37 2021.
- 38 Sec. 504. (Effective from passage) The Department of Administrative
- 39 Services shall develop and implement a plan to provide the personnel,

payroll, affirmative action and business office functions under section 60 of public act 05-251 to additional state agencies, to achieve five

million dollars in savings for the fiscal year ending June 30, 2021.

- Sec. 505. (*Effective from passage*) (a) For the fiscal year ending June 30, 2021, all state employees who are not members of a collective bargaining unit shall take three unpaid furlough days per fiscal year.
- (b) Any unpaid furlough days taken pursuant to this section shall be treated as voluntary schedule reductions pursuant to the provisions in effect on the effective date of this section, of (1) section 5-248c of the general statutes, and (2) section 5-248c-3 of the regulations of Connecticut state agencies, and wage credit for such days shall be in accordance with the practice in effect on the effective date of this section.
 - Sec. 506. (*Effective July 1, 2019*) Each commissioner or chief of any budgeted agency, as defined in section 4-69 of the general statutes, shall implement a hard hiring freeze for the fiscal year ending June 30, 2021."
