***AN ACT ESTABLISHING A GRANT PROGRAM FOR WOMEN AND  
MINORITY-OWNED BUSINESSES.***

Be it enacted by the Senate and House of Representatives in General Assembly convened:

- 1 Section 1. (NEW) (*Effective from passage*) (a) As used in this section:
- 2 (1) "COVID-19" means the respiratory disease designated by the  
3 World Health Organization on February 11, 2020, as coronavirus 2019,  
4 and any related mutation thereof recognized by said organization as a  
5 communicable respiratory disease;
- 6 (2) "Minority-owned business" means a minority business enterprise  
7 as defined in section 4a-60g of the general statutes;
- 8 (3) "Program" means the women-owned and minority-owned  
9 business grant program established pursuant to this section; and
- 10 (4) "Women-owned business" means any business of which fifty-one  
11 per cent or more of the capital stock, if any, or assets are owned by a  
12 woman or women who are active in the daily affairs of the business and  
13 have the power to direct the management and policies of the business.

14 (b) The Department of Economic and Community Development shall  
15 establish, within available appropriations, a women-owned and  
16 minority-owned business grant program for the purpose of providing  
17 grants to women-owned and minority-owned businesses that were  
18 established during or adversely affected by the COVID-19 pandemic, as  
19 determined by the Commissioner of Economic and Community  
20 Development. The department may enter into an agreement, pursuant  
21 to chapter 55a of the general statutes, with a person, firm, corporation  
22 or other entity to operate such program.

23 (c) The Department of Economic and Community Development shall  
24 publish on its Internet web site a notice of grant availability for the  
25 period beginning on the effective date of this section and ending on June  
26 30, 2022.

27 (d) Each women-owned or minority-owned business applying for a  
28 grant under this section shall submit an application in such form and  
29 manner as prescribed by the commissioner. Each application shall  
30 include the following information: (1) The location of the principal place  
31 of business of the applicant; (2) the ownership structure of the women-  
32 owned or minority-owned business; (3) an explanation of the intended  
33 use of the grant being applied for; and (4) such other information that  
34 the commissioner deems necessary.

35 (e) The Department of Economic and Community Development shall  
36 review all grant applications received under the program and determine  
37 which applications are eligible for funding. Criteria for such  
38 determinations shall be established by the department and included in  
39 the notice of grant availability described in subsection (c) of this section.

40 (f) The amount of any grant issued pursuant to this section shall not  
41 exceed ten thousand dollars and the total amount of grants issued shall  
42 not exceed five million dollars. No grant shall be issued pursuant to this  
43 section after June 30, 2022.

44 (g) (1) Not later than January 1, 2022, the Commissioner of Economic

45 and Community Development shall report, in accordance with the  
46 provisions of section 11-4a of the general statutes, to the joint standing  
47 committee of the General Assembly having cognizance of matters  
48 relating to commerce regarding the progress of the program and  
49 including any requisite legislative proposals to accomplish the goals of  
50 the program.

51 (2) Not later than January 1, 2023, the Commissioner of Economic and  
52 Community Development shall report, in accordance with the  
53 provisions of section 11-4a of the general statutes, to the joint standing  
54 committee of the General Assembly having cognizance of matters  
55 relating to commerce. Such report shall include the following data  
56 regarding the program: (A) The number of grants provided and the  
57 amount of such grants; (B) the identities of the businesses that received  
58 such grants, and information regarding whether such businesses were  
59 women-owned or minority-owned; (C) the intended use of each grant  
60 provided, as described by the business pursuant to subdivision (3) of  
61 subsection (e) of this section; (D) the number of employees employed by  
62 each business that received a grant at the time such business received  
63 such grant; and (E) the number of employees employed by each  
64 business that received a grant at the conclusion of the program.

This act shall take effect as follows and shall amend the following sections:
