"AN ACT CONCERNING LEGISLATIVE OVERSIGHT AND APPROVAL OF COVID-19 RELIEF FUNDS."

1 Strike everything after the enacting clause and substitute the
2 following in lieu thereof:

3 "Section 1. (NEW) (*Effective from passage*) Notwithstanding any
4 provision of the general statutes, not later than April 26, 2021, the
5 Governor shall submit to the speaker of the House of Representatives
6 and the president pro tempore of the Senate recommended allocations
7 of federal funds designated for the state pursuant to the provisions of
8 Subtitle M of Title IX of the American Rescue Plan Act of 2021, P.L. 117-
9 2, as amended from time to time, except for any funds designated under
10 the Coronavirus Local Fiscal Recovery Fund. Not later than five days
11 after receipt of the recommended allocations, the speaker and the
12 president pro tempore shall submit the recommended allocations to the
13 joint standing committee of the General Assembly having cognizance of

14 matters relating to appropriations and the budgets of state agencies.
 15 Said committee shall report their approval or modifications, if any, of
 16 such recommended allocations to the speaker and the president pro
 17 tempore not later than May 16, 2021. The final allocations of such funds
 18 shall be authorized by public or special act of the General Assembly.
 19 Disbursement of such funds shall be in accordance with such final
 20 allocations and no disbursement of such funds shall occur prior to such
 21 authorization.

22 Sec. 2. (*Effective from passage*) Not later than April 26, 2021, the
 23 Secretary of the Office of Policy and Management shall submit a report,
 24 in accordance with the provisions of section 11-4a of the general statutes,
 25 to the joint standing committee of the General Assembly having
 26 cognizance of matters relating to appropriations and the budgets of state
 27 agencies. Such report shall include an overview of all funds received by
 28 the state pursuant to the Coronavirus Aid, Relief, and Economic
 29 Security Act, P.L. 116-136, as amended from time to time, and the
 30 Coronavirus Response and Relief Supplemental Appropriations Act,
 31 P.L. 116-260, as amended from time to time, including a full accounting
 32 of all funds that have been disbursed and a plan for the disbursement of
 33 any remaining funds."

This act shall take effect as follows and shall amend the following sections:
