- 10 filing a certificate of organization, including appointment of registered
- 11 agent, one hundred twenty dollars; (4) filing a change of address of
- 12 agent certificate or change of agent certificate, fifty dollars; (5) filing a

13 notice of resignation of registered agent, fifty dollars; (6) filing an 14 amendment to certificate of organization, one hundred twenty dollars; 15 (7) filing a restated certificate of organization, one hundred twenty 16 dollars; (8) filing a certificate of merger, sixty dollars; (9) filing a 17 certificate of interest exchange, sixty dollars; (10) filing a certificate of 18 abandonment, fifty dollars; (11) filing a certificate of reinstatement, one 19 hundred twenty dollars; (12) filing a foreign registration certificate by a 20 foreign limited liability company to transact business in this state, one 21 hundred twenty dollars; (13) filing an application of foreign limited 22 liability company for amended foreign registration certificate, one 23 hundred twenty dollars; (14) filing a certificate of withdrawal of 24 registration under section 34-275h, one hundred twenty dollars; (15) 25 filing an annual report, (A) concerning any year prior to July 1, 2020, 26 twenty dollars, and (B) concerning any year on or after July 1, 2020, 27 eighty dollars; (16) filing an interim notice of change of manager or 28 member, twenty dollars; (17) filing a registration of name or a renewal 29 of registration of name, sixty dollars; (18) filing a statement of correction, 30 one hundred dollars; and (19) filing a transfer of registration, sixty 31 dollars plus the qualification fee."
