Title: AN ACT CONCERNING ENHANCEMENTS TO CERTAIN AGRICULTURAL PROGRAMS.

Statement of Purpose: To (1) include chicken eggs as part of the state-funded Connecticut Farmers' Market/WIC and Senior Nutrition programs, (2) increase fines for violating certain farm product grading and marketing requirements, (3) provide the Commissioner of Agriculture with infraction authority for the violation of statutes under the commissioner's authority, and (4) increase vouchers for said nutrition programs.
