**Title:** AN ACT CONCERNING PARTICIPATION IN THE ELECTORAL PROCESS.

**Statement of Purpose:** To (1) restore, without the payment of certain fines, the electoral privileges of convicted felons who are on parole, (2) codify existing practice, under a memorandum of understanding, regarding voter registration procedures at the Department of Motor Vehicles, and (3) eliminate registrar-appointed challengers from who may be present in the polling place during a primary or election.
