Title: AN ACT CONCERNING THE ACCREDITATION, REPORTING REQUIREMENTS, MENTAL HEALTH, BODY-WORN RECORDING EQUIPMENT, DATA STORAGE SERVICES, TRAINING AND HIRING OF LAW ENFORCEMENT OFFICERS.

Statement of Purpose: To revise the requirements regarding the accreditation of law enforcement units, study ways to lower the costs associated with data storage or services related to body-worn recording equipment, require police officers receive training regarding interactions with persons with mental or physical disabilities, and revise the amount of a grant-in-aid to municipalities for the purchase of body-worn recording equipment.
