**Title:** AN ACT CONCERNING THE REFORMATION OF CERTAIN TAXES AND TAX EQUITY.

**Statement of Purpose:** To reform certain taxes to reduce taxes for middle-class families and enable investments in education, housing, health care and long-term care services, and to require the Labor Commissioner to make a one-time direct payment of five hundred dollars to individuals who experienced economic hardships due to the COVID-19 pandemic and received unemployment compensation benefits between March 15, 2020, and December 31, 2020, inclusive.
