Title: AN ACT CONCERNING FUNDRAISING BY THE FOUNDATION OF THE UNIVERSITY OF CONNECTICUT.

Statement of Purpose: To allow The University of Connecticut to maintain the amount of cash compensation paid to the foundation if the two-year average of funds raised by the foundation for the preceding two fiscal years is not less than five times the average total cash compensation paid by said university to the foundation over the same period.
