Title: AN ACT CONCERNING MINORITY TEACHER RECRUITMENT AND RETENTION.

Statement of Purpose: To improve minority teacher recruitment and retention in the state by (1) establishing the minority candidate certification, retention or residency year program, (2) developing a plan to promote the teaching profession as a career option to students in high school, and (3) develop and require school district personnel responsible for hiring educators to complete a video training module relating to implicit bias and anti-bias in the hiring process.
