"AN ACT CONCERNING THE SAFETY OF CHILDREN WHEN BUYING ICE CREAM FROM A FROZEN DESSERT TRUCK."

- 1 Strike section 5 in its entirety and substitute the following in lieu
- 2 thereof:
- 3 "Sec. 5. (NEW) (Effective July 1, 2021) (a) Except as provided in
- 4 subsection (b) of this section, no person shall vend from a frozen dessert
- 5 truck that is stopped or parked on any highway:
- 6 (1) When the posted speed limit on such highway is greater than 7 twenty-five miles per hour;
- 8 (2) When such highway is less than one hundred feet from an
- 9 intersection with another highway that has a posted speed limit greater
- 10 than twenty-five miles per hour;

- 11 (3) Located less than five hundred feet from any property used as an 12 elementary or middle school, one hour before and one hour after the
- 13 regular school day, unless that day is not a school day and the local or
- 14 regional board of education approves such vending in writing;
- 15 (4) When such person does not have a free and unobstructed view for
- at least two hundred feet in both directions of the highway where the
- 17 frozen dessert truck is stopped or parked; or
- 18 (5) To a person standing in the highway.
- 19 (b) A local traffic authority, as defined in section 14-297 of the general
- 20 statutes, may authorize vending from a frozen dessert truck that is
- 21 stopped or parked on a highway (1) that has a posted speed limit greater
- 22 than twenty-five miles per hour, or (2) that is less than one hundred feet
- 23 from an intersection with another highway that has a posted speed limit
- 24 greater than twenty-five miles per hour.
- 25 (c) No person shall (1) stop on the left side of a one-way highway to
- vend, or (2) back up a frozen dessert truck to vend or attempt to vend.
- 27 (d) A person shall vend (1) when the frozen dessert truck is lawfully
- 28 stopped or parked, and (2) from the side of the frozen dessert truck
- 29 facing away from moving vehicular traffic and as close as practicable to
- 30 the curb or edge of the highway.
- 31 (e) (1) On and after July 1, 2021, and until September 30, 2021, any
- 32 person who violates any provision of this section shall receive a
- 33 warning.
- 34 (2) On and after October 1, 2021, any person who violates any
- 35 provision of this section shall, for a first offense, be deemed to have
- 36 committed an infraction, and for a subsequent offense, shall be fined not
- 37 more than one hundred dollars."
