

Expired and Extended COVID-19 Executive Orders

Issue

This report describes the COVID-19 executive orders (EOs) that expired (as of May 21 and May 29, 2021) and those the governor extended (through June 1, June 30, and July 20, respectively).

Summary

The governor declared public health and civil preparedness emergencies on [March 10, 2020](#), in response to the COVID-19 pandemic. He renewed this declaration on [September 1, 2020](#), [January 26, 2021](#), [April 19, 2021](#), and [May 18, 2021](#), while also declaring new states of emergency on each of these dates. ([SA 21-2](#) ratified the first three declarations and authorized a renewal through May 20, 2021; [SA 21-4](#) extended the renewal authorization through July 20, 2021.)

With the first two emergency declaration renewals, the governor issued accompanying EOs that broadly extended all unexpired EOs from one emergency period to the next. Beginning with the April renewal, however, he extended (through May 20, 2021) only a subset of the unexpired COVID-19 EOs. OLR Report [2021-R-0096](#) provides an overview of these extended orders.

On May 20, the governor issued [EO 12B](#), which:

1. repeals certain orders, or portions of orders, as of May 21, 2021 (Table 1 below);
2. sets May 29 as the expiration date for all orders that are not extended; and
3. extends certain orders, or portions of orders, through June 1 (Table 2), June 30 (Table 3), and July 20 (Table 4).
