Title: AN ACT CONCERNING INSURANCE COVERAGE FOR THE PROVISION OF MENTAL HEALTH WELLNESS EXAMINATIONS.

Statement of Purpose: To authorize Medicaid reimbursement for suicide risk assessments and other mental health evaluations and services conducted at school-based health centers and public schools, and to eliminate the requirement that a mental health wellness examination be conducted by a primary care provider for purposes of insurance coverage.
