Title: AN ACT CONCERNING THE SUBMISSION OF INCOME AND EXPENSE INFORMATION IN CONNECTION WITH THE ASSESSMENT OF INCOME-PRODUCING REAL PROPERTY.

Statement of Purpose: To (1) clarify the process for imposition of a penalty on owners of certain real property for failure to file certain information requested by the assessor, (2) allow for certain filings postmarked within the applicable filing period to be deemed timely, and (3) apply existing billing practices to tax bills issued such owners.
