**"AN ACT ESTABLISHING THE ENGLISH LEARNERS' BILL OF RIGHTS."**

1 After the last section, add the following and renumber sections and  
2 internal references accordingly:

3 "Sec. 501. (NEW) (*Effective from passage*) (a) The State Board of  
4 Education shall not promulgate, authorize, require or include in any  
5 course or portion of a curriculum the following concepts: (1) That any  
6 race or sex is inherently superior or inferior to any other race or sex, (2)  
7 that any individual, by virtue of such individual's race or sex is  
8 inherently racist, sexist or oppressive, whether consciously or  
9 unconsciously, (3) that an individual's character is necessarily  
10 determined by such individual's race or sex, or (4) that an individual or

11 group, by virtue of the individual's or group's race or sex, bears any  
12 responsibility for actions committed in the past by other members of the  
13 same race or sex.

14 (b) The State Board of Education shall adopt regulations in  
15 accordance with the provisions of chapter 54 of the general statutes to  
16 implement the provisions of this section.

17 Sec. 502. (NEW) (*Effective from passage*) No local or regional board of  
18 education shall promulgate, authorize, require or include in any course  
19 or portion of a curriculum the following concepts: (1) That any race or  
20 sex is inherently superior or inferior to any other race or sex, (2) that any  
21 individual, by virtue of such individual's race or sex is inherently racist,  
22 sexist or oppressive, whether consciously or unconsciously, (3) that an  
23 individual's character is necessarily determined by such individual's  
24 race or sex, or (4) that an individual or group, by virtue of the  
25 individual's or group's race or sex, bears any responsibility for actions  
26 committed in the past by other members of the same race or sex."

This act shall take effect as follows and shall amend the following sections:
