Senate Joint Resolution No. 164

*Senate, April 15, 2024*

The Committee on Judiciary reported through SEN. WINFIELD of the 10th Dist., Chairperson of the Committee on the part of the Senate, that the joint resolution ought to be adopted.

***RESOLUTION ACCEPTING THE RECOMMENDATION OF THE CLAIMS COMMISSIONER TO GRANT AN AWARD TO LUIS ORTIZ ON HIS CLAIM AGAINST THE STATE.***

Resolved by this Assembly:

- 1 That the recommendation of the Claims Commissioner, file number
- 2 26177 of said commissioner, that an award of six thousand dollars,
- 3 payable from the appropriation to the adjudicated claims account of the
- 4 General Fund, be granted to Luis Ortiz on his claim against the state, is
- 5 accepted and that payment of said amount to said claimant is ordered.
