Substitute Senate Joint Resolution No. 174

Senate, April 15, 2024

The Committee on Judiciary reported through SEN. WINFIELD of the 10th Dist., Chairperson of the Committee on the part of the Senate, that the substitute joint resolution ought to be adopted.

RESOLUTION VACATING THE DECISION OF THE CLAIMS COMMISSIONER TO DENY THE CLAIM AGAINST THE STATE OF HAYDEE SILVA AND REMANDING THE MATTER TO THE OFFICE OF THE CLAIMS COMMISSIONER FOR A DE NOVO HEARING ON THE MERITS.

Resolved by this Assembly:

- 1 That the decision of the Claims Commissioner, file number 22987 of
- 2 said commissioner, ordering the denial of the claim against the state of
- 3 Haydee Silva, is vacated and remanded to the Claims Commissioner for
- 4 a de novo hearing on the merits. Such hearing shall be heard and
- 5 decided by a temporary or special deputy in the Office of the Claims
- 6 Commissioner who has no prior involvement with said file number
- 7 22987.

The bill vacates the prior denial of the claim by the Claims Commissioner and authorizes Haydee Silva to present a claim against the state to the Claims Commissioner. The associated fiscal impact depends on the adjudication of the claim.
