**Title:** AN ACT CONCERNING PRESIDENTIAL ELECTORS AND THE CERTIFICATION OR DECLARATION OF ELECTION RESULTS.

**Statement of Purpose:** To (1) nullify the vote of, remove and replace presidential electors who fail to cast their vote as pledged, (2) specify that the duties of certain public officials which are related to the certification or declaration of election results are ministerial, and (3) allow that mandamus actions be brought in the Supreme Court to compel such public officials to carry out such duties.
