Title: AN ACT CONCERNING CONSUMER PROTECTION.

Statement of Purpose: To (1) declare the state's policy concerning broadband Internet access service, (2) require certain broadband Internet access service providers to provide affordable broadband Internet access service, (3) require certain fee disclosures and prohibit deceptive and excessive fees for consumer goods and services, (4) prohibit public entities from purchasing or operating certain small unmanned aircraft systems, (5) impose various requirements concerning connected devices, (6) require net neutrality by imposing requirements on certain broadband Internet access service providers, (7) regulate streaming service billing practices, and (8) impose various requirements concerning repairs of electronic or appliance products.
