Title: AN ACT CONCERNING STREET TAKEOVERS AND THE ILLEGAL USE OF CERTAIN VEHICLES.

Statement of Purpose: To (1) revise provisions regarding forfeiture of certain illegally used vehicles, (2) authorize municipalities to adopt an ordinance related to street takeovers, (3) establish penalties for driving while a person's license is suspended or revoked due to a violation related to a street takeover, and (4) establish a grant program to provide funds to municipalities to enforce laws related to street takeovers and the illegal use of certain vehicles.
